e-VERIFICATION

ONCE YOU'VE SUBMITTED YOUR ITR, IT IS IMPORTANT TO VERIFY THE SAME, IN ORDER TO COMPLETE THE FILING PROCESS. **e**-VERIFICATION IS THE EASIEST WAY OF VERIFYING YOUR ITR, AS IT SAVES YOU THE EFFORT OF SENDING SIGNED ITR-V TO CPC BENGALURU.



HOW TO e-VERIFY

YOU CAN **e**-VERIFY USING A) ELECTRONIC VERIFICATION CODE B) AADHAAR OTP OR C) BY LOGGING IN THROUGH NET BANKING. EVC MAY BE OBTAINED USING A PRE-VALIDATED BANK ACCOUNT OR A PRE-VALIDATED DEMAT ACCOUNT.

D) USING DSC

HERE ARE A FEW SIMPLE STEPS TO COMPLETE THE PROCESS:

- Login to e-Filing portal and go to 'e-File' --> 'Income Tax Return' --> 'e-Verify Return'
- Click on the 'e-Verify' link available against the ITR which is to be e-Verified
- Select e-Verification, mode as applicable
- Enter EVC/OTP for e-Verifying your ITR
- e-Verification of ITR is now complete

HERE ARE A FEW STEPS ON HOW YOU CAN FILE ONLINE:



- LOGIN TO THE e-FILING PORTAL AND GO TO 'e-FILE'-->'FILE INCOME TAX RETURN'
- SELECT THE "ASSESSMENT YEAR, "FILING TYPE", ITR TYPE, SUBMISSION MODE
- ♦ SELECT STATUS
- CONTINUE IF YOU ARE SURE ABOUT THE ITR TYPE OR YOU CAN CLICK ON "PROCEED" TO HELP FIND YOUR ITR
- SELECT REASON FOR FILING & FILL THE APPLICABLE FIELDS OF THE ITR
- SELECT VERIFICATION MODE
- FILL ALL THE APPLICABLE FIELDS IN THE ITR
- SEND THE SIGNED ITR-V TO CPC FOR VERIFICATION
- e-FILING OF ITR IS NOW COMPLETE



GOING COMPLETELY ONLINE CAN BE DIFFICULT, ESPECIALLY WHEN YOU HAVE MULTIPLE FORMS WITH A LOT OF DATA AND LABORIOUS CALCULATIONS. SO TO EASE YOU IN, THE OPTION TO DOWNLOAD AND THEN UPLOAD A COMPLETED FILE, WITHOUT THE FEAR OF 'SESSION TIME OUT' IS ALSO PROVIDED..

HERE'S HOW YOU GO ABOUT THE PROCESS:

- DOWNLOAD THE APPLICABLE JSON UTILITY FROM THE e-FILING PORTAL
- ♦ GO TO 'DOWNLOADS' -> INCOME TAX RETURNS
- DOWNLOAD UTILITY
- ♦ FILL ALL THE APPLICABLE FIELDS IN THE ITR UTILITY AND GENERATE JSON FILE
- LOGIN TO THE e-FILING PORTAL AND GO TO go to E-FILE-> INCOME TAX RETURNS -> FILE INCOME TAX RETURNS
- ◆ SELECT THE "ASSESSMENT YEAR, "FILING TYPE", ITR TYPE, SUBMISSION MODE
- UPLOAD THE GENERATED JSON FILE
- ◆ ENTER EVC/OTP FOR e-VERIFYING YOUR ITR (OR) SEND THE SIGNED ITR-V TO CPC FOR VERIFICATION
- e-FILING OF ITR NOW COMPLETE
